Noise Control Ordinance, Cap.400

Using powered mechanical equipment, for the purpose of carrying out construction work other than percussive piling in respect of which a construction noise permit was not in force on 16 May 2010

Notice of Intended Prosecution

I write to inform you that the Environmental Protection Department is considering the institution of the following proceedings against you as a result of using powered mechanical equipment for the purpose of carrying out construction work on 16 May 2010 at the Joint-User Complex and Wholesale Fish Market in Area 44, Tuen Mun, New Territories.

“On Sunday, did cause to be used powered mechanical equipment, namely one lathe, pipe threader (螺紋鉸切機) and one scissor lift (交剪梯), for the purpose of carrying out construction work other than percussive piling in respect of which a construction noise permit was not in force, contrary to section 6(1)(a) of the Noise Control Ordinance, Chapter 400.”

Kindly please note that you are not obliged to furnish a reply unless you wish to do so but your reply will be kept in file and may be given in court as evidence.
